Touring clinics and Avalanche awareness clinics
– Official Contest Rules

ELIGIBILITY: Touring clinics and Avalanche awareness clinics are open to residents of Canada (excluding Quebec), the United States of America, the United Kingdom and New Zealand who have reached the age of 16. Employees, representatives and agents of Oakley Canada Inc., and members of the immediate family (parent, child, sibling and spouses) of all such persons as well as those with whom they are domiciled are not eligible to enter. Void where prohibited by law.

Touring Clinics:

The Contest will begin at 12:00:01 a.m. (Pacific Time ("PT")) on March 5th, 2018 and will end at 11:59:59 p.m. (PT) On March 12, 2018 (the "**Contest Period**").

Avalanche awareness clinic:

The Contest will begin at 12:00:01 a.m. (Pacific Time ("PT")) on February 5th, 2018 and will end at 11:59:59 p.m. (PT) On March 12, 2018 (the "**Contest Period**")

You may enter by going to www.oakleyweek.ca during the Contest Period, following the link and completing all required information on the 'enter' page and clicking 'submit'.

Participation is limited to one entry per person.

All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the Rules (defined below) may be disqualified by Oakley. Oakley takes no responsibility for lost, stolen, delayed, damaged, misdirected, late or destroyed entries, or for typographical, production or other errors. Neither Oakley nor Whistler Blackcomb is responsible for any errors or omissions in printing or advertising the Contest or in these Official Rules.

There are a total of 18 accesses per day (March 15-16) for the Touring Clinics, a total of 18 accesses per day (March 17-18) for the Avalanche awareness clinic.

Prize:

Each prize winners will be entitled to attend the clinics for witch they have won. The following will be available to each prize winners per clinics:

Touring Clinic (Ski and Splitboard)

1. One (1) guides from Mountain Sk Academy (6 to 1 ratio)
2. Rental touring gear * :
 - i. For skiers - Skis, bindings & skins.
 - ii. For snowboarders – Splitboard, skins, bindings, retractable poles.
3. Avalanche safety gear (transceiver and batteries, probe, shovel)

Avalanche awareness Clinic

1. One (1) guides from Mountain Ski Academy (6 to 1 ratio)
2. Avalanche safety gear (transceiver and batteries, probe, shovel)

If the prize winner already own touring equipment, transceiver, probe and shovel we strongly suggest you bring them and use your own. Ensure your transceiver as new batteries.

Touring and Avalanche clinic Rules:

- Participants must be 16 or older
- Both participants need to be present at check-in the day of the event.
- Participants are responsible to have a valid lift access pass for the day of the event
- Participants are responsible to book their Touring or Av kit online through the Escape Route website 48hrs before the event date, using the promotional code they will be provided.
- Each participant must sign a liability release and a rental agreement form before the activity
- Participants under 19 must have a parent or guardian sign their liability waivers and rental agreement.
- Participants must be an Alpine Lessons level 4 or higher
 - Skier: I am consistent on blue runs and sometimes venture onto easy black runs. I might like to learn short turns, moguls, and powder.
 - Snowboarder: I am comfortable linking turns on beginner and easier intermediate runs. I would like to explore more challenging terrain.

Clinic Schedule

- Check in time: 8 AM to complete registration and equipment pick-up at Escape Route Alpine Demo Centre located at 7-4433 Sundial Pl, Whistler, British Columbia V0N 1B4, Canada
- 9 AM : Participants and guides/instructors to depart village and make their way to Flute Bowl zone.
- 10 AM -10: 30 AM : Clinics to commence
- 2: 30 PM: Clinic's completed, participants and guides/instructors to make their way back to the village.
- 3:30 PM to 4:30 PM: All equipment to be returned to Escape Route Alpine Demo Centre

Total approximate retail value of each Prize is \$ 250 CAD* plus applicable taxes. Any difference between stated approximate retail value and actual prize value will not be awarded. The above prize description constitutes the expected Prizes and all aspects thereof are subject to availability and subject to change.
